Key Club Application  
Official Rules & Regulations for Membership

1. An applicant for membership in the Supreme Forest Key Club shall qualify for said membership by submitting a minimum of five (5) petitions for membership in the Tall Cedars of Lebanon, subject to these petitions conforming to the rules set forth herein.
2. Applicant must be first line signer to qualify petition. No other signer or endorser will be given credit for petition.
3. Proposed petition must be balloted upon favorable by the membership of the Forest to which it is submitted.
4. After petition has been acted upon favorably, petitioner must become a member in good standing by being duly initiated and having satisfied the Scribe of said Forest by paying the required initiation fee and dues of the current year.
5. No application will be considered unless properly completed by the Scribe of said Forest.
6. Credit will be allowed only for petitions signed within a five consecutive year period.
7. No application will be considered unless properly completed by the Scribe of said Forest.
8. Applications must be received by the Supreme Forest Office not later than February 1<sup>st</sup> following the year the minimum is achieved.
