# **Extension Report**

Cedars all, Your committee consists of SDSTC Jim Marion 2022 PSTC Joe Russell 2017 PSTC Mark Brumaghim Region 1 director Alex Duenas Roberto Sanchez Region 10 director, as the Chairman

The Tall Cedars of Lebanon have permission to have forest in only 21 of the 50 states.

Some Grand Lodges will give you permission and some Grand lodges will put you on the next years agenda for their annual communications.

We are on the agenda for the 2024 Grand lodge communications for these states. Maine, Arkansas, Oregon, Hawaii, Alaska, and Texas. We have received a NO from these states, New Hampshire, Rhode Island, Colorado, and Utah.

We have not received a response from these states as of today. Vermont, Louisiana, Kentucky, Wisconsin, Minnesota, North Dakota, South Dakota, Iowa, Kansas, Nebraska, Wyoming, Washington, Idaho, Nevada, Montana, and Arizona.



There have been communications with these states, and we are still working with them. California, New Mexico, Mississippi.

We have a Yes, with an approval letter in the supreme forest office for the state of, Oklahoma. Also, the state of North Carolina has said yes, but no approval letter is at the supreme forest office as of today.

We are still working on getting recognition with the states That have yet to respond to us. We must be very cautious with these Grand lodges to have them embrace us and not alienate us.

Moving outside the United States we are getting request for new forest from around the world. The list is long, but we are being cautious and going slow as to not make mistakes. The list includes Ecuador, Paraguay, United Kingdom, Lebanon, Australia and others.

As you know by now, last year we have opened a forest in Mexico City, Mexico. We opened a forest in San Salvador, El Salvador. Over Fathers day weekend this year, we chartered a Forest in Rio De Janeiro, Brazil. The positive responses that we have all received is practically indescribable. While there we made many connections for new forest request along with countries telling us that their masonic membership numbers simply can not support us.

Our extension plans are to continue within the United States but also plan for the future outside of the United States. The world is hungry for masonic bodies, and we cannot miss this opportunity for membership and worldwide recognition.

This is the report of your extension committee.

# 2024 Educational Scholarships

The Tall Cedars of Lebanon International will award five \$1,000 Scholarships for a one- year period according to the following criteria:

A. Awarded annually to a member in good standing of a Job's Daughters Bethel, a Rainbow Assembly, or a DeMolay Chapter in a jurisdiction where a Tall Cedar Forest exists, or be the son, daughter, grandson, or granddaughter of a Tall Cedar in good standing.   - 3. Be of excellent character, personal integrity, leadership, and community involvement;
  - 4. Provide two recommendations from school administrators, guidance counselors, and/or teachers;
  - 5. Provide one personal reference;
  - 6. Provide financial need information;
  - 7. Complete a personal essay of no more than 1,000 words outlining why education is important to themselves;
  - 8. Submit an official school transcript;
  - 9. Complete the Masonic Affiliation form; and
  - 10. Complete a photo/video release form.
- C. Postmark deadline for all applications is March 25<sup>th</sup>, with the awards being made in April.
- D. All scholarship monies will be paid directly to the institution of higher learning.
